## **Tender Notice and Tender submission details.**

Sealed two bid, Part-A & Part-B, quotations in separate sealed covers are invited from financially sound and well experienced manufacturers of food grade chemicals satifying technical specifications & commercial criteria for the supply of food grade laboratory & industrial chemicals as per list for our Packaged Drinking Water plant. The limited tender is in two bids, Part-A Technical & commercial and Part-B Financial bid. The bids have to be submitted in separate sealed covers with marking on the cover part-A or part-B as the case may be, name of the bidder and chemical supply. The separately sealed both covers shall be put in one cover and send to KIIDC office addressed to Managing director. The bid shall be reached at our office within the stipulated time. Part- A bid cover shall contain EMD or line payment receipt, copy of supporting evidences to satisfy pre-qualification criteria and customer list. The EMD shall be paid by DD drawn in favour of Kerala Irrigation Infrastructure Development Corporation Ltd payable at SBI Thiruvananthapuram. The part-B bid shall contain only price item wise as per our list.

The conditions other than our specifically mentioned shall be the same as prevailing in Kerala PWD/Irrigation department regarding supply are applicable to this tender also. Further details if required can be had from the office during working hours.

#### TECHNICAL/COMMERCIAL REQUIREMENTS

The industrial/laboratory chemicals shall be from KIIDC approved manufactures. The KIIDC approved five manufacturers/brands are, Himedia, Nice, TCC, Merck. & US Steriles. The chemicals required are mentioned in the list separately attached. The chemicals shall be strictly of food grade complying BIS standards suitable for using in our Packaged Drinking Water Plant at Thodupuzha near Malankara, Muttam, Idukki District (Kerala). The eligibility criteria required for the bidder shall be as follows. Those who are qualified as per below criteria shall only be considered and their offer will be initially scrutinised based on the documents submitted.

## Pre-qualification criteria of the bidder.

- 1. The bidder shall be either a manufacturer or their authorised supplier/or their authorised sub-supplier of the approved brand/s. The approved make/brands are Himedia, Nice, Merck, TCC, & US Steriles.
- 2. The bidder shall be either authorised supplier or sub-supplier of the authorised supplier of atleast any one of the approved five manufacturers or brands, viz Himedia, Nice, TCC, Merck. & US Sterile.
- **3.** The bidder shall be in the manufacturing/trading business of food grade chemicals for the last two years.

Note 1: Copy of the valid license to manufacture food grade chemicals/authorization issued to suppliers/sub suppliers and experience certificate in this field has to be enclosed along with the technical bid (Part-A) of tender.
