- 2. The words "NAME OF WORK" should be inscribed on envelope of the quotation.
- 3. An EMD of each work listed above in the form of Demand Draft, drawn in favour of the Managing Director, KIIDC Thiruvananthapuram should be included along with the quotation.
- 4. All the quotations must be submitted with photocopy of PAN card, GST, Registration Certificate.
- 5. Bidder shall be responsible for the payment of all type of taxes, as applicable.
- 6. Any damage to the existing building/structure/fencing/wiring/sewer lines/water lines/telephone cables/power cables etc. during carriage of material or otherwise shall be rectified/made good by the applicant/firm.
- 7. The successful bidder shall be responsible for and shall comply all safety measures, labour regulations, traffic rules & timings, provisions etc.

- 8. The bidder shall be liable for any mis-happening, damage at site or outside. KIIDC shall not be responsible for that.
- 9. In case KIIDC is not satisfied with the performance of bidder or progress of works, KIIDC has the right to cancel the work order and forfeit the bid security. The bidder shall not be entitled for any compensation from KIIDC.
- 10. The KIIDC reserves the right to postpone or cancel the tender without showing any reason.

Special Conditions of Contract

The following special conditions shall apply to the contract for the supply of Equipments for water quality testing. The Standard Conditions of Contract (for supply of materials or stores) shall apply except for the provisions mentioned herein. Where they differ from the Standard Conditions, the Special Conditions shall override the Standard Conditions.

- 1. The supply of Equipments for water quality testing should be as per the specifications.
- 2. The validity of the Contract would be for a period of 4 months from the date as will be mentioned in the letter of acceptance. Purchaser reserves the right to extend the Contract for a further period of 3 months on the same rates, terms, and conditions.
- 3. Purchaser reserves the right to increase the quantity up to 30% of the tendered quantity within the period of validity of the contract and on the same rates, terms & conditions. The purchaser also reserves the right to stop taking supply of any item of this contract or reduce its quantity to any extent during the currency of this contract without assigning any reasons.
- 4. The Purchaser shall issue Delivery Orders based on the requirement at the plants. The quantities mentioned in the Schedule are only approximates and are likely to vary. No tolerance will be accepted for late delivery and penalty clause as mentioned in Standard Conditions of Contract shall apply to all late deliveries subject to acceptance of the material by the Consignee and extension of the

delivery date by the Purchaser. Transit insurance must be arranged by the Contractor. It may be noted the quantity supplied should not be more than the ordered quantity. No additional payment will be made for excess quantity, and it will not be adjusted with the subsequent order.

- 5. Packing: Equipments for water quality testing should be packed in transparent polythene bags and then put in to corrugated box. Carton should be designed in a manner that the pack should be able to withstand the transit and storage load. The damaged equipments will be rejected after visual inspection and should be immediately replaced by the supplier. Boxes equipments should be labelled on the outside with the following information:
 - a. Supplier name
 - b. Quantity in Box
 - c. Name of the Consignee
 - d. Date of Production
 - e. Time/Shift of production.
 - f. Batch No

6.Inspection: Inspection/quality test report shall be enclosed with each supply of equipments by the Contractor. Inspection shall also be carried out at the Consignees premises by the officers of KIIDC and the Lot would be accepted by the purchaser only on receipt of the certification from KIIDC. The lot size and sampling method to be employed and tolerance shall be decided by Purchaser at the time of signing of the Agreement. The Rejections would be dealt with in the manner set forth in the Standard Conditions.

7.Payment Terms: hundred Percent payments after receipt and acceptance of the material of contract. No advance payment will be allowed under any circumstances.
