3. The quotations will be opened on 19-05-2025 at 16:30 hours. Quotations will be opened in presence of bidders who may like to attend.
4. The words "Disposal of scrap steel materials of the condemned weigh bridge of Groyne field in Arattupuzha and Pathiyankara of Alappuzha District" should be inscribed on envelope of the quotation.
5. **The bidder must quote the total amount (including all taxes) for the items as per the attached schedule.**
6. An EMD of Rs. 8453/- in the form of Demand Draft, drawn in favour of the Managing Director, KIIDC Thiruvananthapuram should be included along with the quotation.

7. All the quotations must be submitted with photocopy of PAN card, GST Registration Certificate
8. Bidder shall be responsible for the payment of all type of taxes, as applicable.
9. **The bidder shall visit the site before participating in bid process for the works and shall be deemed to be familiar with the site conditions.** The materials are available for viewing for bidders on any working days within office hours at the respective site.

10. The bidder shall arrange to remove the material from the site at his own cost.
11. Any damage to the existing building/structure/fencing/wiring/sewer lines/water lines/telephone cables/power cables etc. during carriage of material or otherwise shall be rectified/made good by the applicant/firm.
12. The disposal of scrap material shall include dismantling the weigh bridge, prefab cabin and all accessories related and loading of materials in suitable vehicle and clearing off from site. This shall be done by mechanical means only. Enough equipment including crane, tipper/dumpers and any other men & machinery to be deployed to remove and dispose the material in stipulated time.
13. During the process of Transportation, the Material should be covered by a thick covering sheet. Observe the prevailing traffic rule and regulations.
14. The successful bidder shall be responsible for and shall comply all safety measures, labour regulations, traffic rules & timings, provisions etc.
15. The bidder shall be liable for any mis-happening, damage at site or outside. KI IDC shall not be responsible for that.
16. In case KI IDC is not satisfied with the performance of bidder or progress of works, KI IDC has the right to cancel the work order and forfeit the EMD. The bidder shall not be entitled for any compensation from KI IDC.
17. The bidder shall coordinate with existing contractor already engaged for the construction of groynes.
18. KI IDC reserves the right to postpone or cancel the tender without showing any reason.
19. Bidder shall comply with all the statutory provisions regarding the work for disposal of scrap material.
20. The successful bidder must remove the entire materials within a period of 45 days from the date of the confirmation order.
21. In those cases where the selected bidder does not produce any required documents or submit the performance security or does not enter into agreement within the specified time limit, the bidder shall be debarred in future from participating in all Government bids for three years and will be recommended for blacklisting by the competent authority.
22. The selected bidder should remit the quoted amount in KI IDC account during execution of agreement.
