Terms and Conditions:

- a. The vehicle should be provided in excellent condition on full time basis (24 X 7).
- b. The vehicle should be maintained in good and cleaning upholstery.
- c. The vehicle should not be more than 10 years old.
- d. The expected usage per month will be 2000 KMs.
- e. It is the responsibility of the firm/ contractor to remit the insurance, taxes and any other statutory remittances on time.
- f. The refilling of the fuel, oil and maintenance of the vehicle should be done by the contractor at proper time.
- g. If the vehicle undergoes any repairs or unable to provide at any day, the firm should arrange alternate vehicle or else KIIDC is liable to deduct the amount equal to the expenditure incurred for alternative arrangement of vehicle.
- h. The deduction is also applicable in cases where the vehicle is not available at the required time.
- i. The rates quoted should be inclusive of all taxes.
