1. Conducting boreholes up to the required depth inside the river at locations given by KIIDC officers at site.
2. Standard Penetration Tests (SPT) at regular intervals.
3. Collection of undisturbed and disturbed soil samples.
4. Necessary laboratory testing (moisture content, Atterberg limits, grain size analysis, triaxial/shear tests, etc.).
5. Preparation and submission of a detailed geotechnical investigation report with design recommendations.
